#### Aim of this Paper

- An important consideration in determining whether the evidence is up to date for Plan preparation is the fact that Local Development Plans are required to have an operational life once adopted of at least 10 years. It is important that the new need due to the longer timescale is identified and addressed. The current Local Development Plan runs until 2021 and a new end date is therefore necessary to comply with national guidance (i.e. 2031).
- 2. The Authority has undertaken a review of the evidence to ensure that it is up to date where ever feasible. Where evidence is awaited a way forward in anticipation of receipt of that evidence is identified. In addition some evidence is reviewed more frequently and does not hold for the life of the Plan. Any future publications will need to be taken account of as the Authority progresses the replacement Local Development Plan to adoption.
- 3. The outcomes of Brexit are unknown (February 2018). The Authority will continue to monitor progress and address issues arising at the appropriate time.
