Replacement Pembrokeshire Coast National Park Local Development Plan Examination

I refer to the above Examination.

I am writing to advise you that in accordance with the Service Level Agreement, and in light of the delay in preparing the Schedule of Matters Arising Changes (MACs) and accompanying documents, I will be suspending the Examination for a period of 14 weeks from 20 December 2019 until 27 March 2020.

This will allow the National Park Authority (NPA) the opportunity to conduct a public consultation on the MAC Schedule between 10th January and 6th March 2020 and prepare a report in respect of the representations received.

Following the closure of the MAC consultation, the NPA should forward copies of all the duly made representations to the Programme Officer. A report should then be prepared which: lists the representations made about each of the proposed MACs; provides; a summary of the main issues raised; and the NPA's brief response to these issues. I will then consider all of the representations about the proposed MACs before finalising my report. The report should be submitted to the Programme Officer by the 24 March 2020.

Normally, all issues arising from the consultation should be capable of being considered through the written representations procedure. Exceptionally, however, I may decide that it is necessary to hold a further hearing session or sessions, to clarify and resolve any
