REPORT OF BUSINESS IMPROVEMENT AND IT MANAGER

SUBJECT: MEANS OF HOLDING COMMITTEE MEETINGS IN THE FUTURE

Purpose of Report

Interim statutory guidance on multi-location meetings, further to section 47 of the Local Government and Elections (Wales) Act 2021 (referred to as "the 2021 Act") has been published. This report asks Members to note both the provisions in Section 47 of the 2021 Act and the associated guidance with regard to the Authority's statutory responsibilities in regard to the provision of multi-location meetings. Members are asked to consider the corresponding options available to the Authority as detailed in this report, agree the desired platform for each Committee for 2021/22 and arrive at a consensus for the future platform required by May 2022.

Introduction/Background

A "multi-location meeting" is defined in the guidance as a meeting of an authority whose participants are not all in the same physical place. In some places these are colloquially described as "remote" or "hybrid" meetings. The Act does not refer to these meetings as "remote", but that they are attended by "persons who are not in the same place".

The Interim Statutory Guidance document clarifies the requirements of Section 47 of the 2021 Act as the following:

- 1. National Park Authorities (as defined as a 'Local Authority') <u>are</u> subject to Section 47 of the 2021 Act requiring that arrangements for multi-location meetings are put in place.
- 2. National Park Authorities <u>are not</u> subject to Section 46 of the 2021 Act requiring Principal Councils to broadcast meetings and make recordings available as, in accordance with the definition, a National Park Authority is not a Principal Council.
- 3. National Park Authorities will be subject to a requirement (for certain) meetings to be broadcasted and recordings made available by May 2022 as National Park Authorities are defined as a 'Local/Relevant' Authority.

In summary, in accordance with the 2021 Act, during 2021/22 meetings must be multi-location but are not required to broadcast; by May 2022 meetings must be multi-location and must be broadcasted.

Below is the list of the Authority's current facilities and to what extent they can meet the requirements for 2021/22 (once restrictions have been lifted). Note: the Authority is not required to fulfil the requirement to broadcast meetings until May 2022 however, as the ability to broadcast is already in place, the recommendation is to continue providing the service. In accordance with the requirement, recordings will not be retained until May 2022.

¹ Broadcasting and Recording is not a statutory requirement for 2021/22

² PCC have not yet published 2021 pricing for the hire of Chambers, Video Conferencing and Webcasting Facilities, however as a guideline, the 2019/20 charging to external bodies is below together with an approximation of costs based on a 4 hour meeting:

- Hire of Chamber: £117 per day
- Webcast £128.50 per hour of webcast = £514:00
- Webcasting Operator: £41.50 per hour (including initial set up and post meeting archiving recording) = £207.50

A typical four hour meeting, based on 2019/20 pricing, would therefore cost £838.50 (not including refreshments or car parking).

May 2022 Recommendation

From May 2022 the Authority will be subject to the requirement to broadcast and record meetings, with the known audio quality limitations due to the construction of both the Green Room at Llanion and Discovery Room at Oriel y Parc, a permanent facility which is fit for purpose must be considered now in order to ensure this is in place.
