Report of the Performance and Compliance Co-ordinator

Subject: Performance Report for the Period Ending 31th December 2021

Introduction

The performance report follows the structure of the <u>Corporate and Resources Plan</u> <u>for 2021/22</u>. This follows the approach of the Well-being of Future Generations Act with seven well-being objectives, with an additional section providing general governance information. Activities responding to Covid 19 recovery have been mainstreamed into work streams under each of the well-being objectives.

The following report presents the performance to date up to 31th December 2021 for monthly data and quarter 1 to quarter 3 (April – December) for quarterly statistics.

An explanation of RAG status is at the end of this introduction report. Some Q1 and Q2 data has been revised following review of some data sets.

Planning Service, Appeals and Enforcement

The % of all planning applications determined within time periods ytd has moved below target at 78.85% compared to Q2. It is however showing improvement compared to 57.61% for the same period in 2020/21. The average time taken to determine all planning applications in days ytd has increased from Q2 and is showing a Red RAG rating at 114.67 days. The Authority has had a substantive increase in the amount of casework through 2021 when compared to previous years. This is being monitored by DM, and the increase maybe a longer term trend or alternatively could be a temporary rebound from the Covid-19 pandemic. This increase in casework has been compounded by staff absences, new staff starting and Covid disruptions. While we consider the longer term situation, we have responded to the immediate issue by employing consultants to address casework and reduce staff workloads, which should address the increase in the time taken to determine applications.

Ytd three appeals have been allowed and two applications for costs at section 78 appeal have been upheld, relating to planning application NP/19/0522/FUL in Q1 and NP/20/0279/FUL in Q2.

The % of enforcement cases investigated within 84 days ytd has decreased from 95.05% in Q2 to 80.63% in Q3, with the average time taken to investigate enforcement cases in days ytd increasing from 59.5 in Q2 to 118.3 in Q3. The average time taken to take enforcement action in days ytd has also increased from 67 days in Q2 to 104.33 in Q3. The Authority is currently in the recruitment process for a Senior Enforcement Officer to add additional capacity to enforcement and planning applications.

Work Programme and Countryside Management

The work programme for PROW and conservation is 'on track.' Due to two major storms (Arwen and Barra) the Countryside Management team have had to also undertake substantial extra work regarding tree clearance.

A number of measures relating to Countryside Management activities across work streams are in amber or red. This is the result of the current need to put these activities on hold due to the operations manager leaving their role and future delivery will need to be considered in the context of wider organisation changes. The Direction Team are currently providing additional GIS support where needed.

In terms of the creation of more accessible circuit walk at reed bed, Freshwater East, the Authority is awaiting relevant permissions from NRW before it can proceed with works on-site.

Conservation

Positive progress has been made across Biodiversity and Connectivity Projects. Three out of 4 farms in the Greening Agriculture Pilot have returned quotes with two Solar Photovoltaic and battery system and one water harvesting system. A process report has been written with the Grants lined up ready to be authorised.

Conservation work party volunteering opportunities resumed within Q1 and have continued with 686 volunteer days and 95 social action days contributing to conservation related activities. There has been 184 volunteer days ytd contributed to conservation wildlife survey or monitoring.

The Conserving the Park scheme is operating a waiting list and is currently closed to new agreements. Stitch in Time RAG actions status is in amber as no funding is currently in place for project continuation, officers are working to seek continuation funding for the project. In December it looked likely that the Pembrokeshire Nature Partnership would have some funding to take forward the partnership in the coming year. However this will be at a reduced capacity from present and there will be no project pot for partners.

Responding to Climate Change Emergency

A number of activities are in amber. Installation of Phase 2 network of Electric Vehicle Charging points is ongoing, however some delays experienced with WPD supplies and wayleave agreements. The worldwide global chip shortage continues to delay the Authority's outstanding electric van orders. However an order for an additional 6 electric vans has been made, bringing the total number of electric vans on order to 13. These will replace the existing fleet of diesel vans. The first two electric vans were delivered in January.

PV Generation at Cilrhedyn has moved from Amber to Green with consultants appointed, tender documents being prepared and the work has been scheduled for Summer / Autumn 2022/23. A demonstration event of electric powered tools and machinery was planned at Castell Henllys for early January.

The Authority has agreed to work with the other 2 NPAs on a procurement project. This work is being led by Snowdonia NPA who have prepared a scoping report.

9 Community decarbonisation projects have been awarded funding through SDF ytd and 3 SDF projects were completed in Q3.

Sustainable Landscapes, Sustainable Places

In terms of Sustainable Landscapes, Sustainable Places Scheme projects the delivery of the community woodland proposal has been delayed, due to the initial land identified being withdrawn. An element of the access proposal was to improve access to Poppit Sands, this work requires a feasibility study. A request has been made to WG for reallocation of funding for feasibility study. The other 5 proposals (including collaborative proposals) are on track to be completed by March 2022

First 1000 Days Project and Education

This action has moved from amber to green following a contract being awarded for the employment of a project officer for the First 1,000 days project. Project planning work and a draft action plan were completed during December.

Castell Henllys has delivered 41 school sessions ytd, with 1,367 participants and this is a positive trend in terms of Castell Henllys recovery for its education services following the impact of COVID 19 on its education provision in 2020/21.

Equality Monitoring Information

% of workforce equality monitoring information has been affected by the move to new HR system and is showing red RAG. For confidential reasons this data could not be upload from the previous HR system, instead we have asked staff to input this data to familiarise themselves with the new system. To ensure that data is captured for all new starters we intend to ask all new starters to complete their data as part of the induction process (confidentially). There has been a slight increase in data recorded on the system between guarter 2 and 3.

Business Continuity Plan/ Approach

The Business Continuity Plan/ Approach was an area identified within the Audit Wales Resilience Report. A draft Business Continuity Plan has been drafted.

Digital Approaches/ Infrastructure

The IT back up infrastructure is complete, and progress is on track in terms of Microsoft 365 implementation with migration of all e-mail complete.

RIDDOR and Conflict Incident

The Authority had 1 RIDDOR incident in Q1 and has had two conflict incidents ytd, with one of those occurring in Q3.

Response time FOI, EIR, SAR

One FOI, one EIR and one SAR response were not provided within required time frames in Q1. All responses were provided in time in Q2 and Q3.
