## CODE OF CONDUCT – Declaration of personal interests for inclusion in the public register of members' interests

The Local Authorities (Model Code of Conduct) (Wales) Order 2008

**ADVICE TO MEMBERS:**

The law, and the Authority's Code of Conduct, require you to declare personal interests. (There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).
