Subject: Standards Committee – Re-Appointment of Independent Member

Purpose of Report

To confirm the re-appointment of Mr John Daniels as an Independent Member of the Authority's Standards Committee.

Introduction

The Pembrokeshire Coast National Park Authority's Standards Committee comprises seven Members:

Independent Members: Mrs Victoria Tomlinson (Deputy Chair);
Mr John Daniels; (Chair)
Mrs Wendy Taylor, and
Mr Phillip Davies.

Authority Members: Dr Rosetta Plummer;
Councillor Dr SL Hancock
Councillor M James.

Terms of office

The Standards Committees (Wales) Regulations 2001 stipulate that:

- (a) the term of office of an Authority Member of the Standards Committee "shall be no more than four years, or the period until that Member's appointment as a Member of that Authority ceases, whichever is the shorter", while
- (b) the term of office of an Independent Member of the Standards Committee "shall be not less than four nor more than six years". This Authority has previously resolved that the term of office for an Independent Member shall be five years.

The 2001 Regulations also stipulate that an Authority Member may be re-appointed for one further consecutive term, whilst an Independent Member is prevented from serving more than one term of office as such a Member.

However, the Standards Committees (Wales) (Amendment) Regulations 2006 (the 2006 regulations) now provides for the re-appointment of an Independent Member for one further consecutive term of **four years** without the need for advertising a vacancy.

Mr John Daniels was appointed as an independent member of the Standards Committee on 13th December 2017 for a period of 5 years and therefore his

appointment will cease on 13th December 2022. Accordingly, it is under the 2006 Regulations that approval is sought for the re-appointment of Mr John Daniels as an Independent Member of the Authority's Standards Committee for a further period of 4 years until 13th December 2026.

Financial considerations

The proposal recommended has no immediate budgetary implications save that if Members did wish to advertise this post this will come with a cost

Legal considerations

The Local Government Act 2000 requires every relevant authority, which in Wales includes County and County Borough Councils, Fire Authorities, National Park Authorities and Police Authorities, to establish a Standards Committee, the composition of which is set out in legislation. The proposal set out in this report complies with the requirements of both The Standards Committees (Wales) Regulations 2001 and The Standards Committees (Wales) (Amendment) Regulations 2006.

Human Rights/Equality issues

One could argue that the non-advertisement of a vacancy on the Standards Committee precludes anyone else from applying. This will be remedied when this particular term of office comes to an end.

Risk considerations

If Members decide not to re-appoint but to advertise the vacancy instead, there is always a risk that no-one would apply. However, the recent advertisement for two new Independent Members resulted in sixteen applications being received, therefore the risk is considered to be minimal.

RECOMMENDATION

That Mr John Daniels be re-appointed as an Independent Member of the Standards Committee for a period of four years until the 13th December 2026.
