The Local Authorities (Model Code of Conduct) (Wales) Order 2008

ADVICE TO MEMBERS:

The law, and the Authority's Code of Conduct, require you to declare personal interests. 4. Details of any corporate body which has a place of business or land in your authority's area, and in which you have a beneficial interest in a class of securities of that body that exceeds the nominal value of £25,000 or one hundredth of the total issued share capital of that body;

5. Details of any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above;

6. Details of any land in which you have a beneficial interest and which is in the area of your authority;

10. Details of any land in your authority's area in which you have a licence (alone or jointly with others) to occupy for 28 days or longer;
