## **ADVICE TO MEMBERS:**

The law, and the Authority's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

6. Details of any land in which you have a beneficial interest and which is in the area of your authority;
7. Details of any land where the landlord is your authority and the tenant is a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above;
8. Details of any body to which you have been elected, appointed or nominated by your authority;

- (a) public authority or body exercising functions of a public nature;
- (b) company, industrial and provident society, charity, or body directed to charitable purposes;
- (c) body whose principal purposes include the influence of public opinion or policy;
- (d) trade union or professional association; or
- (e) private club, society or association operating within your authority's area, in which you have membership or hold a position of general control or management;
