Report of Director of Placemaking, Decarbonisation and Engagement

Subject: Traeth Mawr / Newport Sands – update on outcome of changes to Beach Access by Vehicles, Public Engagement and Next Steps

Purpose of Report

This report provides an update to Members on the outcome of changes to beach access by vehicles at Traeth Mawr introduced in 2023. The report also sets out the results of a public engagement exercise undertaken in 2023. Finally, the report seeks Member support for an identified project to deliver enhancements at Traeth Mawr and for approval to progress with a planning application for those enhancements.

Introduction/Background

On 9th May 2023 the National Park Authority purchased Traeth Mawr with the aim of improving the natural environment and beach safety by making the area car-free. At the same time the number of disabled spaces were doubled from three to six and beach wheelchair access was increased. This report provides an update on the feedback of the first full summer and autumn season of those operational changes.

Between 23/10/2023 and 20/11/2023, the Authority also ran an online public consultation regarding the future of Traeth Mawr. The outcome of that is presented in this report.

Finally, the Authority has a result of both the monitoring of that first year's experience and the feedback from the public developed a specific project plan to improve the physical fabric at Traeth Mawr. This project aims to deliver an enhanced public experience which is significantly more accessible, alongside improvements which will deliver a more resilient physical environment with biodiversity gains. Approval is sought from Members to progress this project to the planning and delivery stage.

Operational feedback

In the initial weeks immediately following the Authority's purchase, the volume of vehicles driving and parking on the beach declined dramatically reflecting the motorists response to a 'soft management approach' of public messaging and in situ signage only. Prior to the start of the summer season proper, that soft approach was bolstered by the installation of physical barriers at both slipways. Those barriers remain in place with the effect that since mid-summer 2023, vehicle access onto the

beach has been limited to authorised vehicles for essential operational purposes only.

During this same period the capacity of the formalised car park that PCNPA operate immediately above the beach has accommodated parking demand with no evidence of displaced parking on surrounding land due to lack of available capacity within the existing car park.

Public Engagement Outcomes

The full results of the public consultation are set out in Annex 1 of this report. In total 107 responses were received in both English and Welsh. Of these the majority of respondents accessed Traeth Mawr weekly and were local residents, however responses were also received from those who accessed Traeth Mawr less frequently (4 who never visited) and included responses from those who resided outside Wales.

An overview of comments is provided here:

Traeth Mawr is a unique landscape that has a special place in the heart of both locals and tourists.

There is evident anger that access to the beach has been stopped for vehicles as well as praise for this decision. Parking fees and alternative public transport options and bike facilities is a current barrier for public access.

There is a theme that current access for the disabled population is not where it needs to be with investment needed for a variety of mobility equipment, parking options, changing places toilets and changing/ cleaning facilities.

Sewage is another concern for many in relation to the impact on health and enjoyment of the coast.

There is a mixed picture in relation to praise for dog access as well as concerns regarding dog management and cleanliness.

The Authority has considered these responses in drawing up a specific project for Traeth Mawr, seeking to use funding available as part of the Special Landscapes Special Places fund.

Project proposal

The Authority has developed a project proposal to enhance the existing car park at Traeth Mawr, to replace and upgrade the existing toilet block and provide an enhanced facility including a Changing Places area. Updated drainage facilities will be provided as part of these changes.

Additional changes proposed include permeable surfaces in the overflow car park, improved ramps to access the beach and 3 permanent beach wheelchair storage areas. Enhanced landscaping and appropriate planting are also proposed to deliver net biodiversity benefits.

An indicative layout is provided in Annex 2. Please note precise details may be amended prior to planning application stage, depending on further technical survey results.

Financial considerations

Current income (financial year 2023/24) from parking at Traeth Mawr is £25,548.

The Authority as part of its wider two-year financial contributions to Pembrokeshire County Council to support public conveniences will be paying approximately £14.6k a year for Traeth Mawr for two years. It is anticipated that some of the capital works programmed will assist in reducing the annual revenue costs associated with running the facility if a more sustainable foul drainage solution and options such as small scale solar PV panels can be incorporated as part of the design.

Anticipated costs associated for the project are in the region of £330 - £350k – this includes ramp improvements to the beach, design costs, capital improvements including toilets, changing places provision and changes to the car park surfaces in the overspill area as well as landscaping and biodiversity improvements. Precise costs will not be identified until further investigation works have concluded.

The Authority has secured grant funding to meet the above outlined costs.

Risk Considerations

As the project is fully grant funded, the financial risks are considered low. In responding to identified priorities from a public engagement the Authority considers it has developed a proposal that should meet public requirements.

PCNPA has liaised with PCC with regards to the public toilet and changing places specification and PCC Officers are supportive of the approach proposed.

Compliance

The proposal seeks to improve facilities and broaden access at the same time as delivering nature gains – this is in accordance with National Park priorities.

Human Rights/Equality issues

In advance of purchase of Traeth Mawr/Newport Sands an equality impact assessment was completed as part of an integrated assessment on implementation of new management practice at Traeth Mawr to stop the practice of Beach Parking (following purchase of dunes and beach). One area of impact identified as part of the assessment was on access considerations for particular groups, in particular reasonable adjustment considerations and potential impacts on disabled people.

One of the recommended actions from the assessment was to monitor complaints in relation to implementation of new management decision, including any detrimental impacts on people with disability related access needs. It was also recognised that there was a wider data/engagement gap in terms of engagement with beach wheelchair and mobility users and wider consultation with stakeholders and community.

The Authority developed an engagement Survey titled 'What do you want for the future of Traeth Mawr (Newport Sands) to ensure access for all? The survey was circulated in English and Welsh. Survey was live between 23/10/2023–20/11/2023, 107 responses were received. 14 responses were received from people identifying as I am a Carer. 11 responses were received from people identifying as I have a physical disability/ mobility issues. 1 response was received from person identifying as I have additional learning needs. 10 responses were received from people identifying as I have young children, 65 responses were received from people identifying as I do not have additional needs impacting on accessing the outdoors, 4 selecting Other and one left blank.

Broad themes from response to question - What would make Traeth Mawr more accessible to you? (please note that cars returning to the beach will not be a consideration) are captured in table below.

The public engagement in Autumn 2023 highlighted opportunities of improving facilities further at Traeth Mawr in particular around removing barriers to access faced by disabled people at the site. SLSP Grant funding is available to support a specific project at Traeth Mawr which would deliver many of the improvements highlighted as desirable by the public consultation.

In response the Authority has developed a project proposal which includes enhanced facility including a Changing Places area, improved ramps to access the beach and 3 permanent beach wheelchair storage areas.

The Authority's approach has also been informed by best practice reports:

- Best practice highlighted within the Mae Murray Foundation, <u>Adapt My Beach Report</u> on How to create manage, sustain and improve an Inclusive Beach (May 2023)
- <u>By All Reasonable Means, Least restrictive access to the outdoors</u> NRW (May 2017)

Biodiversity implications/Sustainability appraisal

Nature conservation gains are inbuilt into the design and include significant additional landscaping and planting. The provision of elements such as e bike charging opportunities will also contribute to the wider sustainability of the scheme.

Welsh Language considerations

Public engagement was undertaken bilingually and any new signage/ further projects will also be undertaken in accordance with the Authority's welsh language standards.

Wider implications

A public consultation will take place as part of Planning application processes.

Conclusion

Initial roll out of the Traeth Mawr changes took place in 2023 and whilst a mixed public response has been received, many people have welcomed the improved tranquillity on the beach and the improved safety resulting from the area being car free. Disabled parking has been increased and the PCNPA inclusion team have liaised directly with residents who had specific access needs in relation to beach wheelchair provision.

The public engagement in Autumn 2023 highlighted opportunities of improving facilities further at Traeth Mawr. Grant funding is available to support a specific project at Traeth Mawr which would deliver many of the improvements highlighted as desirable by the public consultation, with the opportunity to develop Traeth Mawr as a key accessible location in North Pembrokeshire.

Recommendation:

Members are asked to note the feedback from the public engagement undertaken so far. They are asked to support the project identified to improve facilities at Traeth Mawr and to support its progression to planning and delivery stage.



There are comments for and against parking on the beach these have not been included in the report as set out in the initial consultation.


1. Which category would you consider being relevant to your daily life






