Subject:

Purpose of Report

To agree the appointment of Members to the Authority's internal Committees, Groups and External Organisations.

Background

It is the practice at the Annual General Meeting to agree the membership of the Authority, its Committees and Groups, together with Members' representation of the Authority on external organisations. To aid Members in their deliberations, the membership for 2025/26 is set out in Appendix 1. There are only two vacancies, for substitute Members on the Welsh Local Government Association and the Port of Milford Haven Advisory Committee.

It is noted that Authority appointments to the Standards Committee are for 4 years or until the end of the Member's term of office, whichever is the shorter. However Paragraph 21 of the Standards Committees (Wales) Regulations 2001 allows for a Member to be re-appointed for one further consecutive term. You will note that Councillors Hancock and James have now completed 4 years on the Committee, however as the term of office of all County Councillors comes to an end in May next year, consideration could be given to extending their time on the Committee for a further year, with their agreement.

Please note that the membership of the Investigating and Disciplinary Committee, the Grievance Committee and the Appeals Committee will have to be agreed at a later date, once all Chairs/Deputy Chairs have been elected to office.

While Members are reminded that you are expected to serve on either the Audit and Corporate Services or Operational Review Committees, the Annual General Meeting provides an opportunity for you to step aside from serving on a particular Committee or outside body if you so wish. Please indicate at the meeting if you would like to do so.
