CODE OF CONDUCT – Declaration of personal interests for inclusion in the public register of members' interests

The Local Authorities (Model Code of Conduct) (Wales) Order 2008

ADVICE TO MEMBERS:

The law, and the Authority's Code of Conduct, require you to declare personal interests.
