- 4 The National Park Authority is recognised as meeting good practice standards in terms of governance, providing value for money and listening to the views of residents, visitors and partners.


The following report presents the performance to date for the Park Direction Team.


At the mid point of the financial year, most actions are well underway, although staff sickness has caused some delays.
