REPORT OF SDF ADMINISTRATOR

SUBJECT: SUSTAINABLE DEVELOPMENT FUND UPDATE REPORT

Background

The Sustainable Development Fund (SDF) supports innovative sustainable projects that develop and test new ways of achieving a more sustainable living for current and future generations. The funding is to assist projects that focus on demonstrating practical solutions relevant to environmental, social, cultural and economic aspects of life. Pembrokeshire Coast National Park Authority (PCNPA) administers the fund to projects which may range from locally based to those applying across the National Park or a wider area. National Park Authority Members who sit on the SDF Committee are responsible for considering all applications for financial assistance in connection with the SDF and to monitor and review the scheme

Project Applications

Six new applications were received by the SDF Administrator but one application was withdrawn, with the possibility that it might be re-submitted at a later date. There are therefore five new applications for consideration:-

SDF 0363 - Ocean Plastics

Ocean Plastics will recycle plastic waste, including that collected from beaches, to trial and demonstrate the viability of using 3D printing and injection moulding to produce quality products for sale. These products will be made in materials which previously would not have been possible or cost effective using small scale manufacturing.

Funding is sought over two financial years: 2017/18 and 2018/19

Any grant assistance approved for this project will be State Aid as defined under Articles 87 and 88 of The Treaty of Rome and would therefore be offered as 'de minimis' aid under the Commission Regulation (EC) No 1407/2013

SDF 0364 - Solva Care Development Phase

Following the two year Solva Care pilot phase, this project is now moving into its development phase, which will:- build upon the best practice trialled and delivered to date, integrate the voluntary services delivered with those delivering local authority or private domiciliary care, extend the service user base, develop a website, vet and recommend local tradespeople and investigate a model for future financial sustainability into the longer term.

Funding is sought over two financial years, 2017/18 and 2018/19.

SDF 0365 – Slipper Limpet Hemocyanin Study

This project is a research study to investigate the extraction of hemocyanin from the invasive non-native slipper limpet and compare it against existing hemocyanins used in pharma products e.g. for cancer therapy. The project would also develop a plan for slipper limpet extraction and handling for fishermen who catch the limpet as a by-catch.

Funding is sought over two financial years 2017/18 and 2018/19.

SDF 0366 - Sustainable Seaweed Management in the Haven Waterway

This project focusses on the management of seaweed blooms in the Milford Haven waterway as a way to address high nutrient levels affecting the water quality. The proposed pilot will collect seaweed from the waterway and use it as a feedstock for a small anaerobic digestion facility to produce biogas and fertiliser for local use.

Funding is sought in the 2017/18 financial year.

SDF 0367 - Well-being

As part of a wider all Wales partnership project led by Keep Wales Tidy (KWT), the Wellbeing project will record, protect, interpret and increase access to Wellsprings within the Pembrokeshire Coast National Park.

Funding is sought in the 2017/18 financial year

Delayed Projects

As reported in the 2015-16 annual report, the projects listed in the table below were delayed and carried funding forward for payment in 2016-17. All projects listed, with one exception viz. SDF 0343 are expected to submit their final claims and receive payment of the amount indicated by the end of March 2017. SDF 0343 has indicated that they will claim £1,000 less than estimated.

Project Progress

SDF Committee Membership and Policy Review

SDF Committee membership is comprised of six Pembrokeshire Coast National Park Authority ("Authority") Members and six Advisory Members, drawn equally from the Public, Business/Private and Voluntary/Community sectors.

Advisory Members currently serve for a period of four years and by virtue of their knowledge and experience contribute to the decision making process. It is the Authority Members, however, who make the final decision on whether an application should be awarded a grant, the level of grant to be awarded and any conditions to which a grant is to be subject to. Approval was given on 10th August 2016, at a meeting of the full National Park Authority Committee, for a twelve month extension to the term of appointment for current Advisory Members who commenced their appointment in August 2012. This therefore takes their membership up to August 2017. This extension was requested and approved to permit a comprehensive review of SDF Policy and Guidance to take place, before selecting new, or reappointing Advisory Members, for a period of appointment to be determined by the Authority following the review. The review is scheduled to commence in February 2017.

Review of the Sustainable Development Fund 2000-2016

A review of the financial support awarded to projects between 2000 and 2016 was undertaken following a request from the PCNPA Audit and Corporate Services Review Committee. Members wished to ascertain whether public money had been wisely spent, which included an evaluation of whether projects that received funding were still operational today. The report presents an analysis of the public money paid to projects, the match funding attracted, the number of applications considered and reviews the progress or longevity of a randomly selected subset (approximately 10%) of projects after their funding stopped. The Main findings and conclusions from the report are summarised as follows:-

- £2,860,348 of funding was paid out to support 201 projects
- SDF funding attracted £5,285,566 of match funding
- SDF funding contributed to projects with an overall value of £8,145,914
- £86,555 of the funding paid out supported 66 small (<£1000) and Little Green Grants (<£1,500)
- Support to individual projects ranged from a few hundreds of pounds to a small number receiving over £100,000
- Six grant recipients received over £100,000
- 17 of the 21 projects randomly selected for more in-depth analysis successfully achieved their goals and continue to operate to date
- All projects supported delivered one or more of the principles of sustainable development

- Assessment clearly showed that between 2000 and 2016 public money has assisted
 many projects to get started, which once up and running, grow, evolve and flourish,
 and in so doing continue to deliver environmental, social, economic and cultural
 benefits long after the funding ceases. In fact there may be a considerable length of
 time between the end of SDF funding and a project nearing or reaching its full
 potential.
- In conclusion the value of SDF funding to assist projects to get new innovative ideas
 off the ground and to support a degree of experimentation or risk was widely
 recognised, as were the benefits for a better quality of life, not just now but for future
 generations as well.

The report was presented to, and accepted by, the NPA Committee on 30th November 2016.

Funding Fair

The SDF Administrator had a stand at the very well attended Pembrokeshire Association of Voluntary Services (PAVS) Funding Fair, held at the Queens Hall in Narberth on 15th November 2016.

SDF Financial position

The Authority has held an earmarked reserve SDF expenditure for a number of years. This reserve has been called upon to supplement in year expenditure but it is now considered expedient to draw on this reserve and, for 2017/18 only, to add £100,000 to the SDF programme. Therefore the SDF has been allocated £200,000 for the 2017-18 financial year and indications at this point in time are that there will be £1,580 of uncommitted funding to carry forward from the 2016-17 financial year. Out of this allocation £29,575 of funding is already committed to SDF projects and £5,025 for the Little Green Grant. This leaves £166,980 of funding available for new projects. Applications under consideration are requesting £111,155 of funding in 2017-18 and £36,691 in 2018-19, which means that there is sufficient funding available to support all the applications under consideration if they are considered worthy of support. There would also be £55,825 of uncommitted funding still available for other potential projects in 2017-18. In addition there remains a SDF reserve sum of almost £29,000, which could be made available if the quantity and quality of applications received to request funding in 2017-18 warranted it.

Administration of the LGG, and previously the innovation strand of the Sustainable Pembrokeshire Small Grants Scheme is undertaken by PAVS, who have to date received no financial remuneration from the SDF for their work. The number of applications to the fund increased significantly in the last financial year, which coupled with the fact that there has been a 1.5 full time equivalent reduction in the Third Sector Resource Team at PAVS, means that there will be charge for continuing their services commencing from April 2017. After considering the options for future administration of the LGG it was concluded that to pay PAVS an hourly rate for work undertaken provided the best value for money and also retained advantages associated with their well- established links and advice networks providing support to the third sector in Pembrokeshire. The figure of £525 used for budget planning purposes for 2017-18 above is an estimate based on having to process an average of ten applications a year with each application taking seven hours of time to complete. It is likely that this proves to be a generous rather than conservative estimate.
