### 1. Apologies for absence

Apologies for absence were received from Councillor K Doolin, Councillor S Yelland and Ms K Scott (PLANED).

### 2. Disclosures of Interest

Mrs J Mansfield disclosed a personal interest in SDF 0376 Halen Dewi, and Mr AE Sangster in SDF 0375 Power of Pembrokeshire, but both remained in the meeting and played a full part in the discussions on the respective applications.

### 4. Minutes

The minutes of the meeting held on the 11 October 2017 were presented for confirmation and signature.

It was **RESOLVED** that the minutes of the meeting held on the 11 October 2017 be confirmed and signed.

# 5. Sustainable Development Fund Update Report

The report of the Sustainable Development Fund (SDF) Administrator outlined the 5 applications before the Committee for consideration that day. The report also updated the Committee on all current projects and their progress.

The SDF Administrator then went on to report the financial position which showed that £36,762 of uncommitted funding remained available for new projects. Applications received were requesting £39,791 in 2017-18, £24,097 in 2018-19 and £5,603 in 2019-20. Therefore, if all the projects under consideration were deemed worthy of support there would be a slight over commitment of funding available in 2017-18, but the balance deficit of £3,029 was small and the Authority would cover this shortfall.

With regard to the Little Green Grant (LGG) scheme, 3 applications had been received in 2017-18, although only one of these had been

approved. Therefore £3,000 remained committed for allocation to LGG projects. It was reported that administration of this scheme was undertaken by Pembrokeshire Association of Voluntary Services (PAVS) and Ms Livock noted that three more applications had been submitted prior to the latest deadline and these were currently being processed.

The SDF Administrator went on to explain that she would be leaving the National Park Authority at the end of January 2018 for pastures new, and a decision regarding the future of her post was currently under review. Members asked if there were currently any projects to take forward and the Administrator replied that she had attended a funding fair in November when details had been taken for nine potential new projects.

The Committee considered 5 new applications for funding under the
Sustainable Development Fund (SDF). The applications were
considered in detail against the fund assessment criteria, following a brief
presentation by each of the project applicants. The SDF Administrator
reminded Members that a number of the applications included on the
agenda that day contained commercially sensitive information and should
therefore not be shared further or distributed.
