### **REPORT OF MONITORING OFFICER**

### SUBJECT: APPLICATION FOR DISPENSATION

An application has been received from a current member of the Authority, Cllr Paul Harries, of Newport for dispensation from the Standards Committee which will enable him to participate in the forthcoming debate, which is going to be held on the closure of Information Centres in Newport and Tenby. His application as submitted relates purely to Newport.

This application has been submitted on the attached form. Councillor Harries set out his reasons in the application and this is a matter that falls within the discretion of the Members of the Standards Committee.

Under the original regulations passed in the Standards Committees (Wales) Regulations 2001, provision was made for a Standards Committee of local authorities and National Park Authorities to deal with applications from Members of such authorities, for dispensation to speak upon matters in which they have a Personal and Prejudicial Interest. The more detailed basis upon which the Standards Committee could exercise its discretionary power to grant dispensations was set out in the further piece of legislation called the Standards Committees (Grant of Dispensation) (Wales) Regulations 2001.

Members will recall that the Annual training lecture this year referred to the commencement of the new powers contained in the 2016 legislation - the Local Government (Standards Committees, Investigations, Dispensations and Referrals) (Wales) (Amendment) Regulations 2016) which has been introduced to update the original 2001 Orders. In particular Member's attention is drawn now to the introduction of an additional category of general dispensation whereby members may grant a dispensation.

#### "If it appears to the Committee to be otherwise appropriate to grant a dispensation"

This ground is in addition to the original grounds which have existed since 2001. There is no longer any requirement to notify the Welsh Government if the Authority's Standards Committee exercises its powers for a general dispensation. That requirement was abolished in April 2016, when the new amendment rules came into effect.

Councillor Harries, on page 2 of his application, has sought to address the relevant grounds upon which he seeks to advance his case for a dispensation. Members are asked to consider this page particularly carefully together with the final page of his application.

As I have referred to earlier, the matter is one which comes within the Standards Committee's discretion and that discretion has to be exercised in accordance with the normal rules for public bodies to abide by when they do in fact exercise a discretion i.e. reasonableness, proportionality, appropriateness and relevance.

#### **RECOMMENDATION:**

That Members consider Councillor Harries' application for a dispensation to speak on matters pertaining to the Visitor Centre in Newport and decide, if and how to exercise their discretion, as they see fit on the evidence presented to them.
