# Summary

This is an application made under The Town and Country Planning (Control of Advertisements) Regulations 1992 (as amended) for the display of advertisements. Advertisement Consent is sought for a single Interpretation Panel sign relating to the Neolithic burial chamber known as Carreg Coetan Arthur which is situated within a residential cul de sac in Newport Local Centre. The sign will measure 230mm long and 90mm wide and will be placed on the gatepost of the existing small wooden gateway which gives access to the historical site.

The proposed sign is considered to be appropriately sited, and of an acceptable scale, colour and design which is in harmony with the historical context of the site. As such the proposal does not adversely affect the visual amenity of the immediate surroundings or cause any harm to public safety. Accordingly, the advertisement is considered to be compliant with the primary purposes of the national park and subsequent policies 3, 8, 13, 15 and 30 of the Local Development Plan. The advertisement is also in accordance with national guidance contained in Planning Policy Wales, Edition 5 (November 2012), Technical Advice Note 7 – Outdoor Advertisement Control (1996) and the Town and Country Planning (Control of Advertisements) Regulations 1992. As a result the application is recommended for approval subject to appropriate conditions.

The application has been referred to the Development Management Committee as the applicant is the Pembrokeshire Coast National Park Authority.

#### Officer's Appraisal

# **Background and History**

#### 'The Origins Project'

The origins project is part of the 'Makers of Wales' prehistoric strand of the CADW pan-Wales interpretation plan. The funding comes from the Welsh Government's Heritage Tourism Project, which is backed with European funding. The project aims to maximise the economic value of heritage through increasing the volume, length and value of visits to Wales, linking themes of Welsh heritage at national, regional and local levels. The project will also make sure that Wales's outstanding heritage is more accessible and enjoyable to visit – for those who live in Wales and for visitors.

The funding will support the following PCNPA project:

- To enhance the site at Castell Henllys including developing it as a regional hub for the origins and prehistory of Wales
- The upgrading of the Castell Henllys site, together with directional signs and interpretation panels all form part of this project.

In addition, the project is proposing the installation of interpretation panels/sign at various prehistory satellite sites throughout the North of the county within the National Park.

The proposed interpretation panel relates to the Neolithic burial chamber known as Carreg Coetan which is sited within a residential cul de sac in Newport Local Centre. Carreg Coetan Arthur is a small, well-preserved chambered tomb which lies on the estuary of the River Nyfer on low-lying flat land near the sheltered Newport Bay and just over a mile north of the hills of Mynydd Carningli towards which Carreg Coetan Arthur seems to be orientated. Access to the site is via a short 20m walk along the residential road, with parking designated along the roadside to alleviate the disruption of cars to neighbouring properties.

The site is privately owned and is a designated CADW site where an existing CADW sign is situated on a post behind the hedge bank immediately adjacent to the gateway. CADW proposes to replace their existing signs in 2015 however the particulars of the proposals have not yet been specified. There is also another related sign positioned underneath the existing road sign at the entrance of the estate advising that the access to the site is on foot only.

#### **Current Proposal**

This is an application made under The Town and Country Planning (Control of Advertisements) Regulations 1992 (as amended) for the display of advertisements. Advertisement Consent is sought for a single Interpretation Panel to be placed on the existing gatepost of the access gate to Neolithic burial chamber known as Carreg Coetan Arthur. The proposed interpretation panel will be di-bond aluminium and plastic composite, with a dark brown background and white text. The panel will be bi-lingual with approximately 30 words of text. The panel will include the name of the site at the top, a grid reference, statement of who looks after the site, 2 QR (quick response) codes, Pembrokeshire Coast National Park logo and phone number, CADW and Welsh Assembly logos along with the origins icon. The panel will measure 230mm long by 90mm wide and will be placed 770mm above ground to the

base of the advertisement. The sign will not project any wider than the gatepost and will not be illuminated.

# **Key Issues**

In dealing with applications for advertisement the planning authority may consider only two issues; namely amenity and public safety.

Impact on Amenity

In practice, 'amenity' is usually understood to mean the effect upon visual amenity in the immediate neighbourhood of displaying the advertisement, or using an advertisement site, where passers-by, or people living there, will be aware of the advertisement.

Paragraph 3.5.2 of Planning Policy Wales (PPW) notes that:-

"The test in considering an advertisement's impact on amenity is whether it will adversely affect the appearance of the building, or of the immediate neighbourhood, where it is to be displayed. Local planning authorities should therefore consider the local characteristics of the neighbourhood, including its scenic, historic, architectural or cultural features. Because assessment of these factors may appear to involve some subjective judgement, authorities should be consistent in their assessment of visual impact in similar or comparable neighbourhoods or surroundings"

Technical Advice Note 7 – Outdoor Advertisement Control offers specific advice in the case of National Parks advising that close scrutiny of applications for advertisement consent is required. Paragraph 19 states:-

"In National Park, Areas of Outstanding Natural Beauty and conservation areas, stricter controls usually apply to the display of advertisements which do not require the local planning authority's express consent. Applications for express consent also need to be closely scrutinised to ensure that the proposal do not compromise the aims of an area's designation"

In regard of local policy, policy 8 of the Pembrokeshire Coast National Park Local Development Plan (LDP) is a strategy policy which ensures that the special qualities of the National Park will be protected and enhanced. Policy 15 seeks to conserve the National Park, with criteria (a) and (b) resisting development that would cause significant visual intrusion, and/or that would be insensitively or unsympathetically sited within the landscape. Policy 30 (d) seeks to avoid development that is visually intrusive.

The wooden gateway where the proposed interpretation panel will be placed is situated at the northern corner of a residential cul de sac on the right side of the estate road with parking provided along the roadside at the entrance of the estate. The site lives in the privacy of its own fenced and hedged enclosure entered by a small wooden gate. Whilst the interpretation panel will

be visible to neighbouring properties, it is considered that the site is not in a prominent location within the estate.

The proposed sign is considered to be appropriately sited, and of an acceptable scale, colour and design which is in harmony with the historical context of the site and therefore the visual amenity of neighbouring properties is not adversely affected. In addition the proposed sign will not cause any harm to the historical landscape of Newport, the adjoining Mynydd Carningli and the special qualities of the National Park. Accordingly, the proposal is considered to be compliant with Policies 3, 8,13,15 and 30 of the Local Development Plan and can be supported.

Impact on Public Safety

On the issue of public safety paragraph 3.5.1 of the Planning Policy Wales (edition 5) states;

"The control regime does not enable the authority to regulate the subject matter of any advertisement. The test in assessing an advertisement's impact on public safety is whether the advertisement itself, or the exact location proposed for its display, is likely to be so distracting or confusing that it creates a hazard to, or endangers, people in the vicinity who are taking reasonable care for their own and others' safety"

The wooden gateway where the proposed interpretation panel will be placed is situated at the northern corner of a residential cul de sac and as such is not visible from the main road and to passers-by. Whilst the sign will be visible from the residential road and to residents living within the estate, based on the fact that the sign is non-illuminated, appropriately sited and relatively small in size, it is considered that the sign will not be distracting or confusing to road users or pedestrian and as such is unlikely to cause any harmful distraction. Accordingly, it is considered that the advertisement does not affect public safety and is therefore compliant with national guidance.

#### Conclusion

The proposed sign is considered to be appropriately sited, and of an acceptable scale, colour and design which is in harmony with the historical context of the site. As such the proposal does not adversely affect the visual amenity of the immediate surroundings or cause any harm to public safety. In addition the proposed sign will not cause any harm to the historical landscape of Newport, the adjoining Mynydd Carningli and the special qualities of the National Park. Accordingly, the advertisement is considered to be compliant with the primary purposes of the National Park and subsequent policies 3, 8, 13, 15 and 30 of the Local Development Plan. The advertisement is also in accordance with national guidance contained in Planning Policy Wales, Edition 5 (November 2012), Technical Advice Note 7 – Outdoor Advertisement Control (1996) and the Town and Country Planning (Control of Advertisements) Regulations 1992.

#### Recommendation

That the application be approved subject to condition relating to the standard time of 5 years, that the development is to be undertaken strictly in accordance with the deposited plans, that the display shall be maintained in a clean and tidy condition, and shall be removed to the reasonable satisfaction of the local planning authority at the expiry of the standard 5 year period given for advertisement consent.
